## Outstanding Operator of the Year Award

#### David Cook, Town of Valdese

David began his career with the Town of Valdese as a trainee at the Wastewater

Treatment Plant. In 1984 he was promoted to Water Plant Superintendent, a position he held until he retired in July 2004. In December 2009, at the request of the town manager, Dave came out of retirement to once again take on the responsibility of running the water treatment operations, as well as, helping train and prepare future water treatment operators.

According to Valdese Town Manager, Jeffrey Morse, who has worked with Dave for over 31 years, he is a man of great integrity and displays strong leadership qualities. "His concern for his employees has always been at the forefront," says Morse. "He instills professionalism as a trait that he expects from his employees and himself. He has been extremely loyal to the citizens of Valdese." David possesses certification for A-Surface, B- Distribution, Grade IV Wastewater and Grade III Collection. He is a former Chairman of the Western Section of the NCWOA and a former member of the nominating committee of the NCWOA.

## 2012 Operator Spotlight Review



### february: Ray McCall



Ray's career in the industry began as a water operator for the City of Hendersonville, but he spent most of his career working with NC DENR. He considers helping 13 water systems build plants or consolidate with existing systems as his greatest accomplishment. With encouragement

from D.A. Whitner and Don Byers he joined NCWOA in 1979 and was named Operator of the Year in 1983.

### August: Henry Forrest



Henry's career took a sharp turn from music teacher to water operator in 1957 when his landlord and Mt. Pleasant Councilman asked if he wanted a job for the summer as a back-up operator at the water plant. After his first waterworks school, he knew he had found a new passion

and quickly worked his way up to earn his A certification and then accepted a position with the City of Charlotte, where he stayed until he retired in 2000. Henry received many honors over his long career, including NCWOA Operator of the Year in 1977 and from NC AWWA-WEA the Fuller Award in 1987 and the Bedell Award in 1989. Henry also served as president of NCWOA in 1975.

### May: Betty Jones



After a history of working in maledominated fields, Betty jumped into the water industry in 1987 as an operator trainee for the Town of Tryon and within a few years she earned her A-level certification. She was responsible for setting up the first certified lab for the town and was

eventually promoted to plant superintendent. She joined NCWOA in 1990 and later became the first female chair of the Western Section. She also earned the Operator of the Year award in 1993 and the J.A. Younts Award from NCRWA.

## November: Rick langley



Rick started with the Greenville Utilities Commission in 1983 as an entry level operator I and over the course of his career," worked his way up to water treatment plant superintendent - the position he retired from in October 2012. Rick holds several certifications including,

A-Well, A-Surface, and Physical/Chemical I. He is a member of NCWOA, NC AWWA-WEA, and NCRWA. Langley has held many positions with NCWOA and is currently the Chair of the Board of Examiners. He has served as first vice president, president, and past president. ## 2012 Committee Reports...

#### Seminary Committee

The Committee credited operators with 2,796 contact hours from July 1, 2011, thru June 30, 2012. This total is an increase of almost 30% from the same time frame last year. Considering all the budget cuts, showing an increase in attendance is a great sign of the quality of the seminars that NCWOA has become known for. The 9 seminars presented in 2011-2012 were: "Filter Assessment Workshops" in Forest City, "Completing the Cycle - Water Distribution & WW Collections" in Wilson & Hickory (sold out both times), "Man vs. Machine" in Statesville (sold out), "Basics 2012 - Training Tomorrow's Water Leaders Today" in Fayetteville, "The Very Small Groundwater Systems" in Sanford & Wilson, 2012 Remote Lab Tech Day in New Bern, and "Change Management -Maintaining the Front Line's Freedom to Operate "in Concord.

The Seminars Committee also conducted two very successful Advanced Day programs at the 2011 Fall School in Raleigh and the 2012 Spring School in Morganton. We presented "Achieving Excellence & Recognition for your Water Treatment System" in Raleigh to 67 attendees. We presented "Alkalinity & pH from Source Water to Distribution" in Morganton to 95 attendees.

We continued to keep the cost to the operator as low as possible and still generate a profit to assist the Association with operations. Thank you to all the utilities that supported the seminar program with free meeting rooms!

Thank you to all the volunteers of the Seminars Committee and all the speakers for their dedication and commitment to the professional development of all the water system operators in North Carolina.

#### Rules Committee

The committee presented three amendments for board approval at the 73rd Annual Business Meeting held in Raleigh on September 25, 2012. All three amendments were approved and subsequently published for the Association's membership.

First under the Association's by-laws, Article VI, Section 3, Subsection 3.2, the amount of membership dues the Parent Association will remit to each said section was reduced from 25-20 percent. Therefore, Subsection 3.2 states, "In order to aid the organized section in carrying out their activities, the Parent Association will remit to each section twenty percent (20%) of the dues received from members residing or working within each said section each year, following the close of the books at the end of the fiscal year."

Under the Association's Constitution,
Article VI, Sections 1 and 2 were
amended. Section 1 omitted the amount

pay a reinstatement fee equal to the
