In 2015 NCWOA provided 14 seminars across the state, as well as high quality publications, well written technical and human interest articles, and two great week-long Operators schools in Morganton and Raleigh.

In 2015 NCWOA continued to work on its Moodle program, an online supplement to assist operators with school and exam. All attendees of NCWOA Certification Schools are eligible to enroll in this online course that supplements and enhances the materials presented in the week long class. Annual Schools: Sandra Bradshaw reported on progress of Moodle for operators use. Moodle is now available for C level classes. B and A level is estimated to be available for the fall school in 2016. There were 174 attendees for the Morganton School in 2015 and 214 attendees for the Raleigh School.

Seminars Committee: Pam Moss reported that the Association credited operators with 2826 hours. There were 10 seminars presented in 2014-2015. The financial report for the Committee is as follows:

Certified Operators of the Year

A Surface William "Bill" Bateman Town of Andrews

Bill is a 28 year water treatment veteran and has been ORC/Superintendent of his hometown water plant for the past 15+ years. His Upflow Microfloc



Process plant has been awarded the Area Wide Optimization Award from DENR/DWR for the past 6 continuous years.

This outstanding operator and manager holds licenses in A-Surface, A-Distribution, B-Well, Grade II Wastewater and Grade II Sewer Collections. He is also a certified Firefighter, Rescue Technician and Intermediate Emergency Medical Technician. He has served on his local fire department and with his county Rescue Squad for over 20 years. He has acted as a trainer for all of these disciplines through his local community college and other schools throughout WNC. He is readily described as a good listener and planner, a hard worker and as someone who, "Can get the job done right".



B Surface Mark Jones Town of Canton

He is a U.S. Navy veteran and retiree with 20+ years' honorable service to our country. He has been a water treatment plant operator for only 3 years but has demonstrated out-

standing dedication and devotion to making the 1930 facility he works at not only look better but run better. Because of his hard work and excellent leadership abilities he was recently appointed as Interim Superintendent of the 4.0 MGD treatment facility for his home community.

He has also become the primary trainer for his operations staff and has organized and presented training for the 3 water plants in his home county. As mentioned he takes great pride in the care and maintenance of his older plant and is proud that the 50 year old high service pumps runs like a smooth old Swiss watch. He says, "Good maintenance is the key to producing safe and reliable drinking water". He demonstrates great loyalty to the citizens and customers of his community and maintains a very positive relationship with everyone. He is a model citizens which demonstrates outstanding organizational and communitive skills.

C Surface

Tommy Lee Williamson City of Brevard

He is an 18 year veteran working for a small city in the southern Appalachian Mountains of our state with the last 6 of

those years working in maintenance and operations at the water treatment plant. Prior to working at the WTP, he was first a sanitation worker who worked his way up to be the foreman of the sanitation department. He is currently working to obtain his B-Surface license.

He is a longtime member of his City Fire Department as a certified Fireman, serving in that capacity for 12 years. He is described by his nominator as a hardworking man who never complains but works each day with a smile and a very positive attitude. He not only performs his normal operator duties well, but is the first to volunteer to work on special projects or to fill in for other operators when they are out sick or on leave. He frequently does most of the routine and unscheduled maintenance at his water plant. Most of the time without being ask to do it. He is a top notch individual as described by his supervisor.

B Well

Andrew Cox Town of Oriental

He resides in the coastal area of North Carolina near Raccoon Creek. He is currently the PWD and Water Plant Supervisor and holds licenses as a B-Well and B-Distribution operator. He has overseen 6 separate upgrades to the treatment plant which





He has greatly improved the town's maintenance capability, has started a valve exercise program, developed a capitals improvements plan and helped the Backflow Prevention ORC to develop a strong cross connection program.

C Well

Mark Teague Environmental Inc.

He works for and owns a private water corporation located in WNC. He acquired the business from a man named Al Wike who was



a very famous operator in the western part of our state. This awardee is responsible for over 50 utility systems to include water and wastewater systems. He holds certifications in well water, wastewater and well drilling.

He has taken on the responsibility for many small "challenged" water systems and has been appointed by the NC Utilities Commission as the "emergency operator" for many. His ability to run and operate these systems sets him apart from most other operators. To quote the nominator, "He continually puts the interest of the water community first and foremost". Lab Analyst of the Year

He has been serving in our drinking water industry for 28 years now and is the past Northeast

Randy Hawkins



has been an organization that has been very instrumental in his water career.


