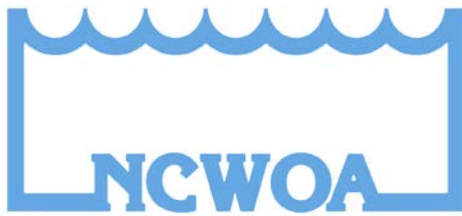
The 2018 sponsors and advertisers in last year's NCWOA Directory and 2017 Advanced Day Exhibitor participants will receive advance notification of this year's show.
