



This recipient has been in the water industry for 10 years, starting with the City of Dunn, then moving on to Fayetteville PWC. He obtained a two year degree from NCSU AG Institute before obtaining several certifications, including

A-Surface and Grade II Physical / Chemical. He has dealt with all aspects of the water treatment process, including operating both of his system's water treatment plants and completing their monthly reports. Unfortunately he had to be sequestered for 31 days, due to COVID, which kept him away from his family but now life is returning to normal. When he isn't working, he enjoys hunting, fishing, and running half marathons.

# Outstanding Operator of the Year

## Object of the Award

The object of the award is to annually recognize one waterworks operator for his/her outstanding ability and devotion to the water supply profession that best merits the title "Outstanding Operator of the Year."

## Basis for the Award

The award may be made by the Outstanding Operator of the Year Award Committee for any of the following reasons: **outstanding proficiency in plant operations, records, and reports; exceptional organizational activities in the award winner's facility, demonstrated educational practices, or investigations leading to improvement of the profession; exceptional devotion to duty, and outstanding service to the Association.**

## Jeff Griebel City of Newton

The recipient of this award has continually strived for improvement, for himself and for his water system. He started working in the water industry in 2012. Along the way, he progressed through the certification exams, earning an A-Surface certification. He did not stop there. He enrolled at CVCC to take night classes in industrial systems technology. The knowledge he gained from those classes has been very useful for his water system. He continues to take more classes, including blueprint reading, electrical wiring, etc.

In 2017, he was promoted to Chief Operator. When he first started the Chief Operator position he still had to work his 12-hour operator's shift. He continued to gain skills and knowledge, including instrument calibration and maintenance. All of this recipient's skills have come into use, as he does everything from repairing leaky faucets to repairing pumps to answering and responding to 2 AM calls. Everyone around him describes his traits as honest, loyal, respectful, compassionate, fair, etc. Jeff is indeed a person who, by his enthusiasm, knowledge, and character, has made everything around him better.

## 2020 Spotlight Recap April



### Angela Hillis - Fayetteville PWC

Angela Hillis, who today works as a Senior Water Treatment operator for the Fayetteville PWC was a 77 Whiskey in the US Army, serving almost 6 years as a Water Treatment Specialist. She just did not know that her military skills would end up being her lifelong work after leaving the Army.

She joined the Army in 1992 at the age of 27 and was sent to Fort Leonard Wood in Missouri for basic training. Eventually she was reassigned to Ft. Lee in Virginia to attend a four-month school to become a Water Treatment Specialist.

In 2019, after serving 20 years with PWC, she was promoted to the Senior Water Treatment Operator there at the Hoffer Plant. She is responsible for daily oversight of the plant, providing help and training to the operators and in seeing that the water is properly treated and delivered to the customers.

### City of Lenoir WTP

No other water system in North Carolina has reacted to these changes and needs more so than the



City of Lenoir. Lenoir owns and operates a 12 MGD conventional water treatment facility located on the banks of Lake Rhodhiss on the Catawba River chain in Caldwell County. The facility serves some 55,000 customers through their and several other purchasing systems.

In January of 2020 the City received their final approval from the state for completion of all of the before mentioned projects. After many years of construction all the projects are completed and the facility is operating in top notch condition.

The staff and the City no longer has to worry about droughts or algae blooms. High raw water turbidity concerns are less because the plant can pre-treat heavy turbidity loading during major rain events. The new filters with air scour produces longer filter runs with less backwash water used and high quality end results.

The chemical feed facilities are virtually all new and reliable and the new SCADA system affords better operational control for the operators. Of course the new laboratory is more user friendly for the operators and probably helps to produce more reliable testing results.

### Tom Muse-City of Asheville Receives "Order of the Long Leaf Pine Award"

Tom Muse began his career working for the Biltmore Estate's Lagoon System. In 1985, he discovered the Asheville North Fork Water Treatment Facility on a drive and decided to apply for work.



He gradually worked his way through the State Operator Program obtaining the highest level licensure for surface water treatment and wastewater treatment in North Carolina. Tom also holds a certification to operate distribution systems.

In 1999, the City opened a new treatment facility in Mills River. Tom again volunteered to help with plant start up. His name is listed as author on many of the operating procedures still in existence today. He has been at Mills River on a night shift for the last 20 years.

## 2020 Spotlight Recap August



### Unprecedented Times

By now all of us water treatment operators are probably well versed on all the happenings and events associated with the COVID-19 pandemic.



First and foremost, our leaders and managers figured out that you, the operator, are the "essential worker" and had to be protected to keep on the job.

In the cases of these two large utilities, both CFPWA and Fayetteville PWC elected to shelter in place their operators in rented mobile trailers placing the operators on site 24/7 and working either a 12- or 8-hour rotating shift.

Speaking with Leslie Carreiro, Water Production Division Manager with Asheville, she indicated that they immediately developed a COVID-19 response plan that included many of the CDC guidelines for social distancing with mandatory use of PPE to include masks.

There are many other areas of our water industry that has been greatly impacted by this pandemic. Water utilities have seen a substantial reduction in revenue because of reduced water turnoffs due to non-payment. Many infrastructure projects have been delayed because of the loss in revenue with some of them not to be completed anytime soon.

The current maintenance supervisor (Robert Bonham) along with input from operations staff designed and fabricated a simple and easy to use "media expansion tool". The tool allows the operator to perform a media expansion analysis in real time during the backwash cycle.




